Payments for these are your responsibility and follow studio due dates.

MONTHLY TUITION PAYMENTS: TDA requires a credit or debit card to remain on file for all accounts. Tuition will be processed through auto-withdrawal on the 25th of the month for the following month's tuition. If you do not wish to use the auto-withdrawal option: payment of cash (only accepted in a labeled envelope), check, or another credit card must be received and balance cleared by the 24th of the month or the card on file will be processed on the 25th.

If you would like to use a different form of payment for Costume and Revue fees, payment must be received and balance cleared by the 9th of the month in which the payment is due or the card on file will be charged on the 10th. If you prefer we run the card on file, please check the "Costume/Revue Fee box," sign, and date below.

Monthly Tuition – Automatic Payment: Fill out the section below and the credit or debit card provided will be charged for your dancer's monthly tuition on the 25th of each month.
